- 1. **Apologies.** There were none.
- 2. **Report from Previous AGM**. There was none.
- 3. **Matters arising**. The Chair explained the background to the change of some of the VH Committee which resulted from the last AGM held on 27th March 2023.
- 4. **Chair's report for 2023**. The Chair introduced the Committee and then in summary:
 - a. VH had been used well in 2023 and remains a valuable asset to the Aynho community.
 - b. Very straightforward year in which the finances held up well.
 - c. We met the challenge of the cost-of-living increases, particularly the heating costs, balanced out with the increased charges, which have since been reduced again.
 - d. The property maintenance continues well (thanks to Ray Willis in particular): Men's toilets have been replaced; emergency exit has had a ramp and rails added; gravel had been added for safety over the winter; and, the VH external signs have been replaced and look more welcoming.
 - e. Inside we have thinned out old stores and made more working space (thanks to Simon Wormald).

- f. Throughout the year we have looked at the responsibilities of the VH Committee and have reviewed governance. We have held useful Committee meetings with a Committee which is representative of the community.
- 5. **Financial Report for 2023**. The Financial summary had been published and was available to Attendees. The Treasurer took the meeting through the various figures for income and expenditure. Hall rental improved by £5000 over the previous year and the expenditure was down £3000. The bank balance at year end was £29,473. Jeremy James was thanked for his work as the Treasurer.
